The raffle is governed by the State of Florida (849.0935, F.S.) Gambling Act. By purchasing a raffle ticket, you agree to be bound by these rules.

1. The purchase price for one raffle ticket is a \$50.00 donation. An indefinite amount of raffle tickets will be sold.
2. Ticket entries can be purchased from an AMP employee or an AMP volunteer.
3. Tickets may be purchased with cash or check. If an Entrant's check is returned unpaid by the bank, the entry ticket(s) will be invalid unless a cash payment is received by AMP by 5:00 PM. Eastern Time Friday, February 3, 2023, the official raffle deadline. Entrant will also be subject to all associated bank fees.
4. All entry purchases are final and non-refundable.
5. Entrant will retain the original printed raffle ticket. The stub will be entered into the drawing and will be retained by AMP.
6. All unsold tickets and proceeds from the raffle ticket sales must be received by AMP no later than 7:00 PM Eastern Time Saturday, February 4, 2023. If received after the official deadline, all monies will be returned to Entrant(s) and all associated tickets will be invalid. Additional tickets may be purchased with cash through AMP at the Hometown Heroes Gala for the Golf Cart Raffle until 7:00 PM on the drawing date, Saturday, February 4th, 2023.
